

Conditions of Participation and Disclaimer of Liability

This event is organized by and under the responsibility of Finfin AG, Aemtlerstrasse 96A, 8003 Zurich, (the organizer).

It is a closed event and access to the event is granted only upon prior notification and/or submission of the legally signed consent form (see below, regarding children).

1. Parents/legal guardians or accompanying persons are obliged to take care of their child / children at any time during the event. The organizer is neither obliged to take care of the children, nor to make them aware of any special dangers.
2. The parents/legal guardians or accompanying persons are aware that they are responsible for the damage caused by their own children.
3. Parents/legal guardians or accompanying persons are aware of any risks of children to get injured while playing and take full responsibility for it.

13. All legal relationships between the organizers and the event visitors are subject to Swiss law. The exclusive place of jurisdiction is Zurich.
